[REDACTED] is currently 19 years old. [REDACTED] reported the [REDACTED] [REDACTED] engaged in sexual conversation with her. [REDACTED] was in a position of power over [REDACTED] at the time and acting as a mentor. The referent advised [REDACTED] told [REDACTED] she was sexually attracted to her. The referent advised [REDACTED] talked about sex toys, masturbation, and asked [REDACTED] to talk about her fantasies.</p> <p>Referent expressed concern because [REDACTED] a month before meeting [REDACTED], therefore [REDACTED] was very vulnerable at the time. 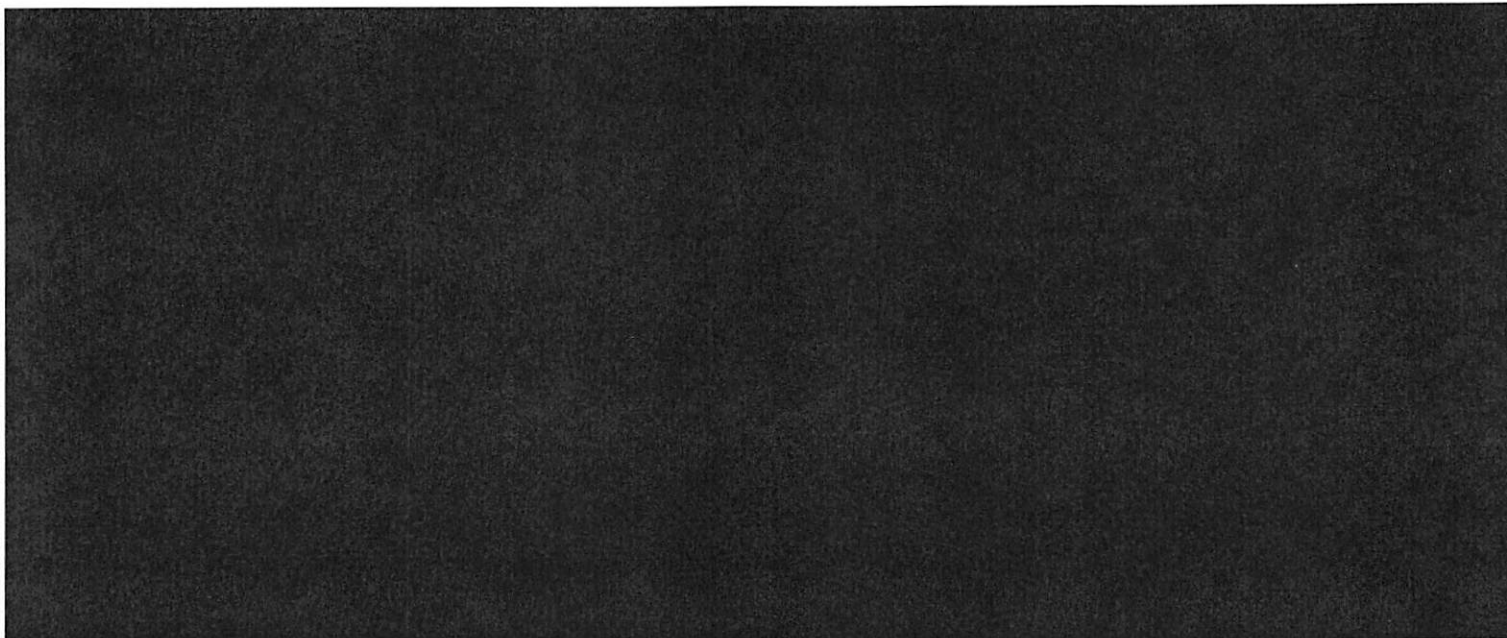

[REDACTED] explained Together We Own Its business hours are 9am-8pm Monday through Thursday during school, but children show up between the hours of 4pm-8pm. [REDACTED] explained during 4pm-8pm the children get help with their homework, talk in groups about their problems, and other different activities. [REDACTED] advised in the summer, Together We Own Its hours are 12pm-6pm Monday-Thursday. [REDACTED] advised each group has their own days when the students can come in. [REDACTED] advised the children must have their own transportation to and from Together We Own It. [REDACTED] advised every child who comes to Together We Own It must enroll in programming and complete an intake, which includes Suicide Risk Assessment, General Family Dynamic Assessments, and Demographic Information.</p>

[REDACTED] advised her and [REDACTED] never engaged in a sexting conversation again. [REDACTED] advised [REDACTED] apologized for the sexting conversation they had and told her it should have never happened. [REDACTED] advised she never engaged in sexual activities with [REDACTED]. [REDACTED] advised she did not feel like she was in a relationship with [REDACTED]. [REDACTED] advised she started getting feelings for [REDACTED], however she advised she pushed her feelings to the side because she did not want to ruin their friendship.

[REDACTED] advised she quit [REDACTED] at Together We Own It because she was not [REDACTED] ok and was around [REDACTED] so much that she was unable to have her "safe place" mixed with her workplace.

[REDACTED] stated [REDACTED] was cursing and hitting her steering wheel out of frustration.

[REDACTED] advised from when she [REDACTED] Together We Own It until 01/09/2023 she would communicate with [REDACTED] via text or Instagram direct messages daily.

[REDACTED] advised the messages were causal and not inappropriate. [REDACTED] advised her and [REDACTED] would hang out frequently as well and have sleepovers.

[REDACTED] advised everyone at Together We Own It noticed how close [REDACTED] and [REDACTED]'s relationship got. [REDACTED] advised Angel made a comment that she wanted to have a relationship like [REDACTED] and [REDACTED] had. [REDACTED] advised at the time, [REDACTED] was never as close with any other people at Together We Own It like she was with [REDACTED].

[REDACTED] advised [REDACTED] "took her under her wing" when she was at Together We Own It because [REDACTED] and she looked up to [REDACTED]. [REDACTED] advised her and [REDACTED]'s relationship was appropriate. [REDACTED] advised she went to Together We Own It because she had a lot [REDACTED]. [REDACTED] explained she did not feel like she benefitted from attending Together We Own It. [REDACTED] advised while she was attending Together We Own It she was close with two staff members, [REDACTED] and Angel [REDACTED].

[REDACTED] advised she stopped going to together We Own It because she got a new housing placement and moved.

[REDACTED] advised she has been [REDACTED] at Together We Own It for approximately one month on [REDACTED], developing a [REDACTED]. [REDACTED] advised Together We Own It is set up differently now then when she went there. [REDACTED] advised she currently texts [REDACTED] and Angel, however she did not text them when she was attending Together We Own It because they kept their numbers confidential from the students. [REDACTED] advised neither [REDACTED] nor Angel have texted her in an inappropriate manner ever. [REDACTED] advised she does not know if anyone has texted [REDACTED] or Angel in an inappropriate manner and does not have any concerns that they would. [REDACTED] advised she did not keep in communication with [REDACTED] or Angel after she left Together We Own It when she was [REDACTED] years old.

[REDACTED] advised [REDACTED] and Angel are involved in their "student" lives and activities. [REDACTED] advised [REDACTED] and Angel have the children's best interest in mind. [REDACTED] advised she does not think Angel or [REDACTED] were specifically close to any children, they were more like mentors. [REDACTED] advised [REDACTED] and Angel are "great people" and care about helping people.

On 02/01/2023 I contacted ASA Seth Giller and quickly briefed him on the case. ASA Seth advised he did not authorize for me to write a Search Warrant for Instagram because there was not enough probable cause. ASA Seth Giller also advised he did not want me contacting [REDACTED] to have her come in for an interview.

I request this case remain OPEN pending staffing with the State's Attorney's Office.
